On completion of course, I was posted to Melbourne for ORDCD training and then headed back to Rushcutter for the ABCD course. In 1968, after two diving accidents,

I was categorised permanently medically unfit to dive and was offered a 'Free' discharge, or transfer to SN. Navy Office finally agreed on a transfer to scribe and I was posted to Cerberus for the Writers course (Ron Dalgleish instructor). On completion of course, I was posted as Carrier Air Group (CAG) scribe to Albatross/Melbourne. In 1969, I was embarked in Melbourne when the collision with USS Frank E Evans occurred.

In January 1970, I was posted to Tarangau (Manus Island) as PNG Patrol Boat Squadron scribe. When not embarked in Aitape, I shared an office, among other things, with 'The Wog' Watson.

In January 1971, I commenced the first of two five-year postings to Leeuwin (JRTE/NOCWA), my Home Port. In December 1975, I was posted as a PO to Perth as Captain's Secretary and then, after numerous 'paper' postings, thanks to Glen MacAndrews, I returned to Leeuwin in October 1976 as a CPO. Ex POWTR R132212. I joined the navy as a 16-year-old JR on 6/10/1982, to run away from school. After completing JR school (and my HSC) in nine months, I went to 'sunny' Cerberus for the Writer school and then moved to Nirimba for my first posting in September, 1983. After two years there, being trained in all aspects of 'writering' by the likes of McAndrews, Eagles, Russell, McAndie, Irwin and Biddle (to name a few), I was posted to Success as Standby Crew, working in 'exotic' places like Zetland and Co-Dock.

After six months of setting up the ship's stores and initial registry, I swapped postings into Cook as the Pay and Accounts WTR for 14 months. This was my first sea posting and the first time my ship 'crossed the line'. What a blast! I then got 'sentenced' to 18 months in Navy Office and did penance in DNMP, DNOP and a little time at Harman. The opportunity presented itself for a posting to Coonawarra in August, 1987 and how could you say "no"?
